Wish for Our Heroes granted 231 wishes for the period ending November 30th, 2015. The 231 wishes resulted in providing assistance to more than 41,000 individuals associated with U.S. Military. The grants ranged from basic needs such as food, housing, transportation, child needs, household goods, and basic home expenses, to recreational wishes such as sporting events. Revenue received that is directly programmatic is in-kind revenue, and that totaled \$1,726,883. Grants were disbursed in 24 of the 50 states and 1 foreign country where U.S. troops are serving.
